# BACKGROUND

- 1. As the Panel is aware, Barnsley MBC is provided with a grant for 1 April 2022 to 31 March 2023 of up to £65,260 as the host authority in respect of the South Yorkshire Police and Crime Panel. Payment of the Grant is subject to standard terms and conditions of the Home Office Grant Agreement.
- 2. The Home Office Grant Agreement stipulates at paragraph 3.1 of Schedule 3 that the recipient shall submit an Annual Report detailing progress against Key Performance Indicators (KPIs) and reporting requirements in support of the year-end claim. At a minimum the Annual Report shall give particulars of the:
  - a) The number of public meetings held;
  - b) Scrutiny documents and publications produced, including the Panel's Annual Report; and
  - c) Engagement with the work of the Panel by Members of the public and the Police and Crime Commissioner for South Yorkshire.
- 3. To demonstrate that the Panel has met the Key Performance Indicators for the municipal year 2022 to 2023, a report of the work undertaken by the Panel is attached at Appendix A.
- 4. Members are invited to consider and comment on the draft Police and Crime Panel Annual Report 2022-23, prior to the report being finalised and published on the Police and Crime Panel's website at <u>www.barnsley.gov.uk/sypcp</u>
