The companies are selected by the organisation who has bid for funds by competitive tender and we have no input at this stage. We make sure the works are carried out to conform to the relevant British Standard and are completed and commissioned before we allow the funds to be transferred. The companies are all third party certificated to install sprinklers.

SSCR grant funding is allocated to organisations who successfully meet the criteria of the sprinkler fund, SYFR do not procure the installation or manage the work it is the responsibility of those who have received the grant.

- To ascertain the position regarding the replacement of the boilers at the CPC stations.

Lowedges and Edlington – Surveys suggest the boilers have at least ten years' life left in them and there are no plans therefore to replace them as part of the current improvement programme.

Aston Park and Tankersley – The boilers at these stations will be fully assessed when the final surveys take place though our maintenance company has only very recently confirmed that they are in good working order.
