SYFR requires its suppliers to adhere to the National Living Wage (NLW) and bidders must allow for this in their pricing. It is a requirement of the contract that any subcontractors required to perform services on behalf of the successful bidder are also paid the appropriate NLW, as applicable to the roles involved.

Extract:-

(Supplement to NEC3 TSC Clause 20)

20.3.12 ensure that all staff and any sub-contracted staff employed to perform the service under the contract are paid as a minimum, the National Living Wage.

## Minute 16 Review of Injury Awards Policy

i) That Members would be provided with a comparison of the total annual cost of paying the injury awards to the 92 individuals, against the current total annual cost of paying the firefighter pensions.

#### Response – Emailed to Members by Mel McCoole on 10 August 2018

DCFO Blunden has indicated that the cost pre-review was £694,845 per annum and post-review was £507,240 per annum. This amount is paid from the Service's revenue budget.

The pension costs prior to the review starting were £16,536,202 which is funded directly by the Firefighters Pension Scheme (not the Service).
